#### TOPICS DISCUSSED

- 1. Point-in-time (PIT) Shelter Survey Training.** Andy Hall of the Arizona Department of Economic Security (DES) Homeless Coordination Office distributed materials to be filled out and submitted for the 2010 Annual Homeless Shelter Survey (Materials were previously emailed to all those responsible for survey completion.) plus the policies and clarifications regarding PIT shelter surveys issued January 15<sup>th</sup> by the U.S. Department of Housing and Urban Development (HUD). He reviewed the process and terminology, and answered participants' questions. He emphasized that it is crucial that all emergency shelter, transitional housing, and supported housing providers submit their completed surveys no later than the deadline, February 5. He thanked TPC members for being the first Arizona continuum of care to comply last year.
